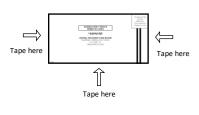
How to use the Business Reply Envelope?



Step 1 Fold along the dotted lines. Fold the top and bottom sections inwards with the mailing address in front.



Step 2 **Enclose your documents** within the sleeve created in Step 1.



Step 3 Completely seal the edges with clear tape to secure your documents inside.

Notes on paying your levy by GIRO:

- The monthly levy will be deducted on the 17th of every month (or the next working day if the 17th is a weekend or public holi day). If the deduction is unsuccessful, you will be charged a late payment penalty. Bank charges may apply for unsuccessful deductions.
- If you have an existing GIRO arrangement, the levy will continue to be deducted from that account until this new GIRO application takes effect, unless otherwise notified. • The GIRO arrangement will be used for levy payment of all existing and future foreign workers, until it is terminated, or a new GIRO arrangement overrides it. Please
- terminate your GIRO arrangement if you would like to stop deductions from this bank account.

Before your GIRO takes effect, please pay your levy using PayNow QR in Check & Pay Levy by the due date as stated in your levy bill to avoid late payment penalties.

		3. Use your mobile banking app on your phone to scan the QR code or import the QR code image.
		4. Check the details of the fund transfer. Make sure you see "Foreign Worker Levy" as the registered payee
		before submitting your request.
